## Open Water Diver Referral Program

### 2 Sections Required Online Academics – Classroom & Pool

After completion of your class and you show mastery of the Pool skills we will sign your referral form in your logbook. This will allow you to finish up your training dives with a different instructor on vacation.

#### Prerequisites for Entering the Course:

Anyone who is in good health, reasonably fit, and comfortable in the water can earn this certification.

Medical Questionnaire and Liability releases are required **prior** to enrolling.

- 200 yard freestyle swim test and a 10 minute float in water too deep to stand in.
- Minimum age: 10

**\$299\*** Must purchase Mask, Fins, Snorkel and Boots on Same invoice to take advantage of special

**\$349\*** if Mask, Fins, Snorkel and Boots not purchased at time of registration
